Batch Replacement, Extension and Reactivation Of Video Lectures of Fast Education

These lectures are recorded for CA/CS/CMA students only. Providing required verification details is mandatory. Lectures are to be viewed by single user who provided identification details at the time of purchase and cannot be shared or transferred to another person in any case. Users from any other stream need to seek prior permission before buying lectures.

These lectures can be viewed on laptops only (or on android mobile phone where ever option is available for the same).

Management has all rights reserved to block the lectures in case of any misconduct, misuse or false information.

DELIVERY AND ACCESS OF DIGITAL PRODCUTS

Digital Product is delivered through Online Download or Pen Drive Mode as per nature of the product. In case of Pen Drive mode, a pen drive is just used for delivery of product and it is advisable to transfer the digital content to your device before using it. FAST is not liable for any warranty/replacement of such pen drive.

Digital products can be accessed using some specific application provided along with product. Certain features like Speed viewing, book marking etc. may be available in application, but it completely depends upon configuration of your device. If your device does not support any such feature then FAST education will not be liable and product will not be taken back in such a case.

BATCH REPLACEMENT:

We provide replacement of Batch:

Within 1 month of purchase - at 50% provided not more than 10 lectures have been viewed and books will not be replaced.

After 1 month - the Full price of the new lectures will be charged and discounts shall be at the discretion of the management.

NO REFUND AND EXCHANGE OF PRODUCT:

Any product in Digital or Physical for cannot be returned or exchanged with any other product released after purchase.

EXTENSION POLICY:

Extension will be charged at Rs. 1000 per subject per month with maximum extension of 4 months from date of expiry of validity. **Extension will be provide only for one time**.

First time reinstallation on the same laptop in which lectures were first installed, in justified cases, will be free of cost and at the discretion of management. Second time reinstallation on the same laptop, will be only at the discretion of management and charged at 1000 per installation.

Lectures once registered on a laptop will not be reactivated on any other laptop in any case.

Multiple lectures purchased under any combo offer must be activated on same laptop.

BOOKS AND UPDATES:

For products that includes physical books, available version will be dispatch. Any version released after dispatch of books to student can not be provided in any case. Same policy is also applicable for digital books option. However Changes/Updates made in latest version may be provided in digital form.

Any amendment released after recording of batch will be provided in the digital form as separate recordings only through the online view/download mode. This is also applicable for students who opted for Pen Drive mode.
